**UPDATE TO PEEP**  
**Policy Entry and Edit Package**  
**August 6, 2007**

This announcement is intended for customers using PEEP, the Policy Entry and Edit Package.

Modifications have been made to PEEP that will allow the user to use this product more effectively. The changes correct various reported issues pertaining to the functions of PEEP and include needed updates. Some modifications include:

- User Requested Enhancements
  - The Create Submission File function includes a Date Sent field and the Transmission Version ID is incrementing per WCPOLS specification.
  - The order of policies found in a Submission file now matches the order of policies as they are being selected to be added to a submission file. This allows for User verification.
- Clarification on Error Reports to provide the User with English descriptions of record types, where errors can be found, and elimination of unnecessary edit failure reports.
- WCPOLS Updates – includes new endorsements and recently added fields
- Modifications to state specific edits
